ST. LOUIS SOLAR'S STATUS REPORT AND MOTION TO HOLD THE CASE IN ABEYANCE FOR ONE WEEK

EXPEDITED CONSIDERATION REQUESTED

St. Louis Solar, LLC ("St. Louis Solar") makes this filing pursuant to the request from the Administrative Law Judge ("ALJ") at the prehearing conference held on July 15, 2020 to file a status report on or before July 22, 2020. The ALJ held the case in abeyance for seven days to provide the parties time to confer with their clients and with each other. At this time, St. Louis Solar and Portland General Electric Company ("PGE") have not yet been able to confer on this matter. St. Louis Solar respectfully requests that the case be held in abeyance for an additional seven days, in order to provide the parties an opportunity to confer.

Abeyance will affect the filing deadlines of three pending or potential filings by St. Louis Solar to respond to the two filings made by PGE. First, PGE filed a Sur-Reply to St. Louis Solar's Motion to Dismiss or, in the Alternative, to Strike PGE's Counterclaims ("PGE Sur-Reply"). Second, PGE filed a Motion to Strike or, in the Alternative, For Leave to File Sur-Reply to St. Louis Solar's Motion to Dismiss or, in the Alternative, to Strike PGE's Counterclaims ("PGE's Motion to Strike and Leave"). St. Louis Solar anticipates it may file three items: 1) a response to PGE's Motion to Strike and Leave; 2) a motion for leave to file a

sur-response to PGE's Sur-Reply; and 3) St. Louis Solar's sur-response. PGE has reserved its right to reply to item 1, and to respond in opposition to items 2 and 3.

PGE filed its Motion to Strike and Leave and its Sur-Reply on Tuesday, July 14, 2020. The parties agree that St. Louis Solar's three filings would ordinarily be due on Tuesday, July 21, 2020. The case was abated such that St. Louis Solar's response (including any related motion) is currently due on Tuesday, July 28, 2020.

St. Louis Solar requests a one-week abeyance of this case to toll the time for St. Louis Solar to file its three pending or potential filings, by seven days, or from Tuesday, July 28, 2020 to Tuesday, August 4, 2020. There are no other pending filings in this docket, so the abeyance will not affect any other pending due dates.

PGE supports the motion for abeyance.
