Complainant Zena Solar, LLC ("Zena Solar") and Defendant Portland General Electric Company ("PGE") are actively conferring in an effort to agree on a proposed procedural schedule for this proceeding. If the parties succeed, they plan to file their proposed schedule with the Public Utility Commission of Oregon ("Commission") by Friday, April 10, 2020. The parties anticipate they will ask the Commission to approve any proposed schedule by Tuesday, April 14, 2020.

In the meantime, and to preserve the status quo while the parties use this week to negotiate, the parties have agreed to the following short-term deadline extensions:

- 1. Extend the end date of the temporary interim relief period from April 17, 2020, to April 30, 2020;
- 2. Extend PGE's deadline to respond to Zena Solar's motion for interim relief and preliminary injunction from April 13, 2020, to April 24, 2020; and
- 3. Extend PGE's deadline to file an answer to the complaint from April 16, 2020, to April 29, 2020.
