

**JOINT MOTION TO MODIFY
PROCEDURAL SCHEDULE**

Expedited Consideration Requested

Pursuant to OAR 860-001-0420, Complainant Zena Solar, LLC (“Zena Solar”) and Defendant Portland General Electric Company (“PGE”) respectfully request that the Public Utility Commission of Oregon (“Commission”) issue an order modifying the procedural schedule in this case by: (1) extending the date for PGE to file its answer from May 5, 2020, to May 11, 2020; (2) extending the date for Zena Solar to file its response to any counterclaim from May 13, 2020, to May 18, 2020; and (3) extending the date for the parties to select a procedural path from May 15, 2020, to May 18, 2020.

The purpose of these extensions is to provide the parties time to explore a possible settlement. The parties have discussed the extension and agree it is appropriate and will not adversely impact the remaining deadlines in the schedule. If this motion is approved, the procedural schedule in this proceeding would be:

PGE Response to Zena Solar Motion for Interim Relief and Preliminary Injunction	May 29, 2020 (to be reviewed by May 18, 2020)
Interim Relief Period Deadline	June 30, 2020

Zena Solar and PGE are not proposing to modify any other deadlines proposed under Path 1 or Path 2 in the parties' April 17, 2020 Joint Motion to Modify Schedule.

The parties request expedited consideration and a ruling by May 5, 2020.
