PGE and Belvedere Solar are parties to a Settlement Agreement filed as a supplemental filing to Advice No. 20-09, Schedule 136, dated May 14, 2020 ("Settlement Agreement"). PGE and Belvedere Solar are also parties to a Public Utility Regulatory Policies Act ("PURPA") standard power purchase agreement (the "PPA"). The complaint in this docket concerns Belvedere Solar's desire to terminate the PPA and participate in the Community Solar Program ("CSP"). Under the Settlement Agreement, PGE agreed to offer an option to terminate the PPA and that certain surviving provisions (namely section 9.5) of the terminated PPA would not apply to any CSP power purchase agreement, and Belvedere Solar agreed to request that this docket be stayed if the Commission approved PGE's Schedule 136. PGE and Belvedere Solar confirm that the Commission's actions at the May 19, 2020 public meeting are sufficient to constitute approval of PGE's Schedule 136 for the purpose of the Settlement Agreement.
