Expedited Consideration Requested

Pursuant to 860-001-0420, Portland General Electric Company (PGE) respectfully submits this Motion for Extension of Time to file its written comments per Chief Administrative Law Judge (ALJ) Nolan Moser's memorandum issued on March 16, 2023.


Currently, the Parties' written comments on scoping questions are due on March 28, 2023. PGE is scheduled to file its first combined Integrated Resource Plan/Clean Energy Plan on March 31, 2023. Many of the PGE staff working on that docket are the same ones who would contribute to completing answers to the scoping questions posed in the memorandum, which must be viewed also in light of the significant list of topics presented in Staff's report of February 9, 2023, that require evaluation in responding to the scoping questions.

PGE requests a minimum of one-week and a maximum of a two-week extension of time for parties to file written comments, and requests the remainder of scheduled events per the ALJ's memorandum be adjusted accordingly by the same time increment.

PGE provided parties on the service list with an opportunity to object to or support PGE's request for extension and has received support from PacifiCorp and no objections from any other party. PGE also requests expedited consideration of this Motion given that the deadline for filing its written comments is March 28, 2023.
