Staff of the Public Utility Commission of Oregon (Staff) moves to modify the procedural 9 10 schedule for this docket. The current procedural schedule for this docket lists the date on which 11 Portland General Electric Company (PGE) may file a Request for Acknowledgment of a Final 12 Shortlist. While this date is discretionary, there are two related events that are definitively set in 13 the schedule. These are 1) PGE shares Initial Shortlist with IE and Staff (currently scheduled on 14 April 12, 2024), and 2) PGE provides Final Short List and Supporting Workpapers, Including 15 Sensitivity Analysis to IE and Staff. Staff proposes to clarify these requirements by changing the 16 date for these two events to be based on the date by which PGE files its request for 17 acknowledgment of the Final Shortlist, respectively, 60 days prior and 30 days prior. The 18 procedural schedule for remaining dates may be set after PGE files the Initial Shortlist. 19 In addition, Staff proposes to modify the next two procedural events so that each is a 20 filing in the docket rather than information to be shared with the IE and Staff. This change will 21 provide greater transparency and allow any other authorized parties to be served with the filings. 22 Staff counsel notified interested parties of its intent to file this motion on March 7, 2024. 23 Staff counsel requested parties respond with their position by close of business March 11, 2024. 24 PGE indicated it has no objection and no other party responded.
