PACIFICORP'S MOTION FOR MODIFICATION OF THE DEADLINES FOR A MOTION TO DISMISS AND ANSWER

**Expedited Consideration Requested** 

1 Pursuant to ORS 756.512 and OAR 860-001-0420, PacifiCorp d/b/a Pacific Power 2 moves for modification of the deadlines to file a motion to dismiss and answer in the above 3 captioned docket. For good cause shown, PacifiCorp respectfully requests that the Public 4 Utility Commission of Oregon (Commission) grant PacifiCorp's request to modify (1) the 5 deadline to file a motion to dismiss from April 29, 2024, to May 17, 2024, and (2) the 6 deadline to file an answer from May 7, 2024, to May 17, 2024. Because these deadlines 7 are fast approaching, PacifiCorp requests that the Commission consider this Motion on an 8 expedited basis. 9 The complaint in this docket was filed and served on April 4, 2024, and an amended 10 complaint was filed and served on April 17, 2024. Pursuant to OAR 860-001-0400(4)(a), 11 PacifiCorp has 20 days from the filing of the amended complaint to file its answer. 12 Pursuant to OAR 860-001-0420(3), PacifiCorp has 10 days from the filing of the amended 13 complaint to file any motions against the initial pleading, including a motion to dismiss.

1 PacifiCorp is still evaluating whether it may file a motion to dismiss, and it anticipates that

2 the answer and motion to dismiss would include common facts and arguments. In the

interest of efficiency, PacifiCorp seeks to file its answer and motion to dismiss as a single

4 filing by May 17, 2024.

PacifiCorp conferred with Complainants and Complainants do not object to this

6 Motion.

7 Because the deadlines for the motion to dismiss and answer are fast approaching,

8 PacifiCorp requests that the Commission expedite its consideration of this Motion. For the

foregoing reasons, PacifiCorp respectfully requests that the Commission enter an expedited

order modifying the original motion to dismiss and answer deadlines and allowing

PacifiCorp to file its answer and motion to dismiss as a single filing by May 17, 2024.
