Docket UP 384 is considering the application of 11 Joint Applicants SRW and NW Natural Water of Oregon, LLC ("Oregon Water") for approval of 12 the Membership Interest Purchase Agreement ("MIPA") pursuant to which Sunriver Resort 13 Limited Partnership intends to sell all of its membership interests in SRW to Oregon Water. 14 The MIPA expressly contemplates that certain assets of SRW would be transferred to 15 SRLP prior to closing and would not be assets of SRW when that transaction closes. The assets 16 addressed in this application are the assets owned by SRW that are excluded from the sale of 17 SRW to Oregon Water. SRW requests that the Commission consolidate proceedings on this 18 application with those in UP 384 because these matters are related. SRW intends that the 19 schedule adopted for UP 384 would continue to apply to the consolidated proceedings. 20 SRW requests expedited consideration of this motion to consolidate. Direct testimony of 21 the Joint Applicants in Docket UP 384 is due to be filed by January 17, 2019. SRW intends to 22 address the matters covered by this Application in its direct testimony and, therefore, requests 23 that the Commission grant this motion to consolidate in advance of that filing. 24 25
