In the Matter of SUNRIVER WATER LLC, Request for a General Rate Revision

MOTION FOR GENERAL PROTECTIVE ORDER

**Expedited Consideration Requested** 

Pursuant to ORCP 36(C)(1) and OAR 860-001-0080, Sunriver Water LLC ("Sunriver Water" or "Company") moves the Public Utility Commission of Oregon ("Commission") for the entry of a general protective order in this proceeding. Good cause exists to issue a protective order to protect commercially sensitive and confidential business information related to the Company's pending general rate revision. Because the Company's responses to certain Staff discovery requests ("DRs") are due on July 8, 2021, Sunriver Water requests that the general protective order be entered on an expedited basis.

In support of this motion, the Company states:

1. The Commission's rules authorize Sunriver Water to seek reasonable restrictions on discovery of trade secrets and other confidential business information. See 860-001-0080; ORCP 36(C)(1) (providing protection against unrestricted discovery of "trade secret or other confidential research, development, or commercial information"). See also *In re Investigation into the Cost of Providing Telecommunication Service*, Docket No. UM 351, Order No. 91-500 (1991) (recognizing that protective orders are a reasonable means to protect "the rights of a party to trade secrets and other confidential information" and "to facilitate the communication of information between litigants").

1 2. On May 28, 2021, Sunriver Water filed its application for a general rate 2 case. Staff submitted its first set of DRs on June 24, 2021. Certain information in 3 response to Staff's DRs in this docket include confidential material, including 4 confidential employee data. Specifically, Staff DR 32 requests the following: 5 "Please provide the redacted confidential information referenced in the Company's 6 response to guestion 22 in the application, the wage/salary column." Public 7 disclosure of the confidential information could be detrimental to Sunriver Water 8 and its customers. 9 3. "The Commission's standard blanket protective order is designed to 10 facilitate discovery in cases involving discovery of large numbers of documents." 11 See In re Portland Extended Area Service Region, Docket UM 261, Order No. 91-12 958 (1991). Issuance of a protective order will facilitate the production of relevant 13 information and expedite the discovery process. 14 Sunriver Water requests consideration of this Motion to allow parties 4. 15 that execute the protective order to obtain prompt access to the confidential 16 information that will be submitted in support of the Company's request for a general 17 rate increase and to expedite discovery in this proceeding. 18 For the foregoing reasons, Sunriver Water requests entry of a general 19 protective order in this docket. 20 III21 III22 /// 23 ///
