4	Pursuant to OAR 860-001-0420(2) and (6), all the parties to this proceeding, namely	
5	Sunriver Water LLC, Staff of the Public Utility Commission of Oregon ("Staff") and Sunriver	
6	Owners Association ("SROA") (collectively, the "Parties"), jointly move the Administrative Law	
7	Judge (ALJ) for a ruling suspending the procedural schedule in this docket. The Parties request this	
8	suspension because the Parties have negotiated a settlement proposal that will resolve all issues.	
9	The settlement proposal is acceptable to Sunriver Water and Staff. In the case of SROA, only its	
10	Board can approve settlements. SROA's Staff and lawyers will recommend the settlement proposa	
11	be approved when the SROA Board considers it at the Board's next meeting on January 15, 2022.	
12	The Parties anticipate filing, on or before Monday, January 31, 2022, a stipulation, supporting	
13	testimony and witness declarations, and a motion to admit the stipulation and exhibits and adopt the	
14	stipulation. No Party objects to this joint motion. In light of the January 19, 2022, due date for the	
15	filing of Staff and intervenor opening testimony, expedited consideration is being requested.
