11	Oregon (Staff) moves the Administrative Law Judge (ALJ) for a ruling amending the procedural		
12	schedule in this docket. On May 18, 2023, Judge Mapes issued a pre-hearing conference		
13	memorandum establishing a procedural schedule for this docket.		
14	On August 7 and September 9, 2023, Parties conducted settlement conferences and made		
15	substantial progress towards settlement of all issues in this proceeding. Public Utility		
16	Commission Staff (Staff) and Seavey Loop Water Company (Seavey Loop or Company), jointly		
17	the Stipulating Parties, have reached a settlement on all issues in this docket, other than the cost		
18	of affiliate labor, and intend to file a partial stipulation supporting this settlement. Intervenors,		
19	Carrie Rose and Diana Chin, oppose the terms of the settlement. Having been informed of its		
20	terms, thus far, Intervenor Yeager St. John, has not expressed opinion on the settlement.		
21	All Parties to this proceeding, Staff, the Company, and Intervenors, have agreed to the		
22	procedural schedule, below, for the the remaining of this proceeding. The proposed procedural		
23	schedule first addresses the Settlement and Partial Stipulation, and then provides process to		
24	resolve the final contested issue, the cost of affiliate labor.
