2. SP Newsprint operates a mill in Newberg, Oregon involved in the newsprint and recycling business. SP Newsprint is a partial requirements customer taking service from Portland General Electric Company ("PGE") under Schedule 75, a schedule developed for large customers with on-site generation.

3. PGE filed a request with the Commission to revise its general rates on March 15, 2006. In its filing, PGE has proposed significant revisions to the partial requirements tariffs that will have a direct and substantial impact on SP Newsprint.

4. For the reasons stated above, SP Newsprint has a direct and substantial interest in this proceeding that will not be adequately represented by any other party.
