4. The nature and extent of the Petitioner's interest in the proceeding is:

Petitioner has a substantial interest in the outcome of this proceeding. Petitioner has approximately 13 facilities in PGE's service territory and purchases approximately 33 million kWh annually from PGE. Petitioner's costs are affected by PGE's rate structure and the rate increase requested by PGE, if approved, would result in significant added cost to Petitioner.

5. The issues the Petitioner intends to raise at the proceeding are:

Petitioner has begun to review and analyze PGE's filing; however, it has not yet developed a precise statement of the specific action sought or a factual and legal basis for such positions. Without limiting Petitioner's request for full intervenor status, Petitioner can state that one focus at the time of filing this petition is on rate design and cost of service issues raised in this proceeding.

6. The special knowledge or expertise of the Petitioner that would assist the Commission in resolving the issues in the proceeding is:

Petitioner participates in over 30 rate case and other rate-related dockets a year around the country. Petitioner's case manager has personally testified in over 70 rate case and other rate-related dockets before 32 state utility regulatory commissions.
