Vitesse is a limited liability company that is wholly-owned by Facebook, Inc.

Vitesse owns and operates a large data center in Prineville, Oregon ("Data Center"). The

Data Center is within the service territory of Pacific Power & Light Company ("Pacific

Power") and is comprised of one or more facilities.

Pacific Power's 2021 Transition Adjustment Mechanism ("TAM") could have a direct and substantial impact on Vitesse, which has a direct and substantial interest in the TAM. Pacific Power's 2021 TAM proposes an overall rate decrease, and a number of changes to how the company models power costs, the calculation of the Consumer Opt Out Charge, and the calculation of the Company Supply Service Access Charge. Vitesse purchases power for the Data Center from Pacific Power pursuant to the Schedule 48 rate approved by this Commission. Without intervention, Vitesse would not have the ability to participate in the proceeding, which could result in material harm.

Vitesse's intervention will assist the Commission in resolving the issues and will not unreasonably broaden the issues, burden the record, or delay this proceeding. Finally, Vitesse's interest is not adequately represented by any other party in this proceeding.

WHEREFORE, Vitesse respectfully requests that the Commission grant its petition to intervene with full party status in this proceeding and to appear and participate in all matters as may be necessary and appropriate, and to otherwise fully participate in the proceedings.
