3. AWEC is an incorporated, non-profit association of large energy

consumers in the Western United States, with offices in Portland, Oregon. Many members of

AWEC are customers of PacifiCorp (or "Company").

4. On June 16, 2022, PacifiCorp filed two proposed tariffs: 1) Schedule 7 –

Low-Income Discount implementing a residential low-income bill discount for qualifying

customers; and 2) Schedule 92 – Low-Income Discount Cost Recovery Adjustment establishing

the cost recovery mechanism for the new low-income discount, along with a balancing account

and automatic adjustment clause. The calculation of such costs and how they are passed along

to customers will substantially and directly affect those of AWEC's members who purchase

power from PacifiCorp. AWEC requests leave to intervene in this Docket to represent its

members who are affected by any change to PacifiCorp's rates and programs.
