3. AWEC is an incorporated, non-profit association of large energy consumers in the Western United States, with offices in Portland, Oregon. Many members of AWEC are customers of PacifiCorp (or "Company").

4. On February 14, 2024, PacifiCorp filed its 2024 Request for General Rate Revision, the purpose of which is to revise its schedules of rates and charges for electric service in Oregon, effective January 1, 2025. The Company is requesting an overall increase in rates of approximately \$322.3 million, or 17.9 percent. Any adjustment to PacifiCorp's rates will substantially and directly affect those of AWEC's members who purchase power from PacifiCorp. AWEC requests leave to intervene in this Docket to represent its members who are affected by any change to PacifiCorp's rates and programs.

5. AWEC represents the interests of a number of large customers served by PacifiCorp in Oregon. AWEC also has significant experience participating in proceedings involving PacifiCorp's rates and programs. AWEC's intervention in this proceeding will assist the Commission in resolving the issues in this proceeding and will not unreasonably broaden the issues, burden the record, or unreasonably delay this proceeding.
