- 4. The City of Portland is centrally concerned with the outcome of this proceeding and its effect on rates, service, and utility management.
- (a) PacifiCorp is one of two private electric utilities serving customers within the City's geographical boundaries. PacifiCorp provides electricity services, utility management, and related services to the citizens of Portland. Under authority of its city charter and state law, the City has the responsibility and obligation to protect the interests of its citizens in public utility matters;
- (b) The City has broad authority under its home rule charter to oversee the activities of utilities within its boundaries, including through the establishment of franchises and the issuance of permits, and is also responsible for the orderly management of public rights-of-way within its boundaries;
- (c) The City has responsibilities under its home rule charter to oversee the activities of utilities within its boundaries, including through the establishment of franchises and the issuance of permits, and is also responsible for the orderly management of public rights-of-way within its boundaries. The Portland City Council has exercised this authority in adopting Portland City Code ("PCC") 17.24.010(A), which requires that a permit be obtained from the City Engineer before any public utility may work in the public right-of-way. PCC 17.24.010(B) restricts the issuance of street construction permits to persons holding current franchises or other grant of authority from the City;
- (d) PacifiCorp operates within the City under the authority of a twenty-year electricity franchise granted by the City Council in October, 1986 (Ordinance No. 159059). The franchise is due to expire in October, 2006. PacifiCorp's franchise with the City establishes the terms and conditions for the utility's use of the streets and public ways within the City for transmitting and distributing electrical energy and for constructing, operating and maintaining poles, conduits and other facilities, including a reporting requirements for energy conservation measures undertaken within the City; and,
