Pursuant to ORS 756.525 and OAR 860-012-0001, PacifiCorp respectfully petitions to intervene in this proceeding. In support of this petition, PacifiCorp states:

- 1. PacifiCorp is an electric public utility in the state of Oregon and is subject to the jurisdiction of the Public Utility Commission of Oregon ("Commission").

- 3. Applicants filed their application pursuant to the provisions of ORS 757.511. Upon approval of the application and the closing of the proposed transaction, the Applicants will exercise substantial control over the policies and actions of Cascade Natural Gas Corporation within the meaning of ORS 757.511. As an electric public utility in the state of Oregon and being subject to ORS 757.511, PacifiCorp has an interest in the issues raised in this proceeding, including any approval conditions proposed by the parties or the Commission.
- 4. Since 1988, PacifiCorp itself has filed applications with the Commission regarding changes in ownership, control or corporate structure. In 1988, the Commission approved the merger of the former PacifiCorp, a Maine corporation, with Utah Power & Light Company pursuant to ORS 757.480. In 1999, the Commission issued an order authorizing Scottish Power plc to exercise substantial influence over the policies and actions of PacifiCorp, pursuant to 757.511. In 2001, the Commission granted PacifiCorp Holdings, Inc. authorization under 757.511 to exercise substantial influence over the policies and actions of PacifiCorp. In 2006, the Commission authorized MidAmerican Energy Holdings Company to exercise substantial influence over the policies and actions of PacifiCorp pursuant to 757.511.
- 5. PacifiCorp has experience with proceedings under 757.511. PacifiCorp's participation here may assist the Commission in resolving the issues before it. PacifiCorp will not unreasonably broaden the issues, burden the record, or unreasonably delay the

proceedings. No other party can adequately represent PacifiCorp's interests in this proceeding.

6. PacifiCorp discussed intervention in this proceeding with MDU Resources Group, Inc.'s counsel, who indicated no objection.

WHEREFORE, PacifiCorp respectfully requests that the Commission grant this petition to intervene.
