XO has an interest in the subject matter of this proceeding. XO is a competitive telecommunications services provider authorized to provide local exchange service in the State of Oregon. XO offers intrastate telecommunications services within Oregon, including local exchange service and intrastate long distance service. XO purchases unbundled network elements (UNEs) from Qwest Corporation (Qwest), pursuant to the parties' interconnection agreement, in order to provide those services.

On June 22, 2007, Qwest filed a petition in this docket requesting that the Commission approve additions to Qwest's non-impaired wire center list. Qwest's petition could impact the rates that Qwest offers its wholesale customers, such as XO, if wire centers were added to the non-impaired list and certain products and services thus became unavailable to competitive providers at UNE rates in those wire centers. Changes in the rates XO is charged for wholesale services that it purchases from Qwest could impact XO's ability to offer the products and services it offers in Oregon. XO therefore submits this Petition to Intervene because it is materially interested in, and will be substantially affected by, the Commission's resolution of the issues presented in this proceeding.

V.


XO's appearance and participation will not unreasonably broaden the issues, burden the record, or unreasonably delay this proceeding.
