Level 3 is a registered and competitively classified telecommunications company authorized to provide both intraexchange and interexchange telecommunications services throughout Oregon. Level 3 currently competes with, and obtains interconnection and related services and facilities from, Verizon Northwest Inc. ("Verizon") in the provision of Level 3's telecommunications services. And, Level 3 maintains local interconnection agreements with Verizon in its capacity as an incumbent local exchange carrier, entered into pursuant to sections 251 and 252 of the Communications Act of 1934, as Amended by the Telecommunications Act of 1996, Pub. L. 104-104, 110 Stat. 56, 47 U.S.C. Sections 151 *et. seq.* (the Act" or "1996 Act").

Level 3 has a substantial interest in the proposed transfer of control of Verizon to Frontier Communications Corporation ("Frontier"). Verizon is the second largest incumbent local exchange carrier in Oregon.
