- 2. T-Mobile is a CMRS telecommunications company authorized pursuant to federal law to provide wireless telecommunications services throughout Oregon. T-Mobile currently obtains interconnection and termination services and facilities from Qwest and CenturyLink entities including: Qwest Corporation, Qwest Corporation f/n/a/ US West Communications, Inc. (collectively "Qwest"), United Telephone Company of the Northwest, CenturyTel of Oregon, Inc. and CenturyTel of Eastern Oregon, Inc. (collectively "CenturyLink") in the provision of T-Mobile telecommunications services. Additionally, T-Mobile purchases certain backhaul services from Qwest.
- T-Mobile has a substantial interest in the proposed merger between and transfer of control of Qwest to CenturyLink. T-Mobile relies upon its interconnection and termination services and facilities which it obtains from both Qwest and CenturyLink to offer and provide telecommunications services to T-Mobile customers in the Qwest and CenturyLink to offer and provide telecommunications services to T-Mobile customers in the Qwest and CenturyLink service territories. Accordingly, T-Mobile seeks to participate in this proceeding in order to ensure that the proposed merger and transfer of control will not adversely impact competition in Oregon nor adversely impact T-Mobile's continued rights and ability to obtain the interconnection and related services and facilities it needs to provide its telecommunications services.
- 4. T-Mobile believes that the proposed transfer of control of Qwest and CenturyLink poses a variety of issues that the Commission will naturally be considering when evaluating what is in the public interest and how to maintain a healthy competitive telecommunications environment in Oregon. T-Mobile's briefing and evidence presented, if any, on the issues of relevant to T-Mobile, will be of material value to the Commission in its

determination of the issues raised in this proceeding, particularly because it is a CMRS PETITION TO INTERVENE

provider that will provide a wireless perspective in this proceeding. T-Mobile's intervention

in this proceeding will not unreasonably broaden the issues to be considered by the

Commission nor will it burden the record or delay this proceeding, per OAR 860-012-0001.

T-Mobile first became aware of the June 22, 2010 deadline for filing a Petition to Intervene

set by the Prehearing Conference Report after that date. T-Mobile agrees to abide by the

schedule set forth in the Report and its late-filed petition will prejudice no party.

raised during the proceeding.
