3. AWEC is an incorporated, non-profit association of large energy

consumers in the Western United States, with offices in Portland, Oregon. Many members of

AWEC are customers of PacifiCorp (or "Company").

4. On May 14, 2019, PacifiCorp requested authorization to defer

approximately \$4.8 million of expenses starting in 2019 that are associated with the incremental

costs of fire risk mitigation work. On May 14, 2020, the Company requested reauthorization to

defer approximately \$27.4 million of expenses starting in 2020 that are associated with fire risk

mitigation. Ultimately, PacifiCorp deferred a total of \$7.9 million. Both requests are pending

before the Commission. If approved, the Company's requests will substantially and directly

affect those of AWEC's members who purchase power from PacifiCorp. AWEC requests leave

to intervene in this Docket to represent its members who are affected by any change to

PacifiCorp's rates and programs.

5. AWEC represents the interests of a number of large customers served by

PacifiCorp in Oregon. AWEC also has significant experience participating in proceedings

involving PacifiCorp's rates and programs. AWEC's intervention in this proceeding will assist
