1 3. 2 This case and two others relating to rate recovery for PGE's Trojan nuclear plant, 3 DR 10 and UE 88, are now pending before the Commission in joint remand proceedings. 4 PacifiCorp is a party to DR 10, but not the other two cases. 5 4. 6 On April 19, 2007, the Commission issued Order No. 07-157 in the combined cases 7 DR 10/UE 88/UM 989. In that order, the Commission held the first phase of the proceedings in abeyance and immediately commenced the second phase to investigate the Commission's delegated authority to engage in retroactive ratemaking. Given "the 10 generality and breadth of the issue," the Commission recognized that other parties would want to participate in the case. Accordingly, the Commission directed that the schedule 12 accommodate the intervention of additional parties. 13 5. 14 PacifiCorp has a direct and substantial interest in this proceeding, given the 15 fundamental ratemaking principles implicated. While PacifiCorp could potentially continue to participate as a party to DR 10 only, it is moving to intervene in this case and UE 88 to 17 ensure its ability to fully participate in the proceedings. 18 6. 19 PacifiCorp's participation may assist the Commission in resolving the issues before 20 it. PacifiCorp will not unreasonably broaden the issues, burden the record, or unreasonably 21 delay the proceedings.
