Special Promotion for Available Inventory Collocation Sites Amendment to the Interconnection Agreement between Qwest Corporation and United Communications, Inc. dba Unicom For the State of Oregon

This Amendment between Qwest Corporation ("Qwest") and United Communications, Inc., dba Unicom ("CLEC") provides for limited time, promotional rates for Available Inventory Collocations on Available Inventory Sites, which are identified at http://www.qwest.com/cgi-bin/wholesale/collocation.cgi. The Parties acknowledge that they have previously entered into an Interconnection Agreement in the applicable state.

Limited Time Offer. The promotional rates provided for herein apply only to Available Inventory applications received between January 2, 2005 and March 31, 2005. The collocation applications must be submitted through the normal channel via rfsmet@qwest.com.

Requirement for Collocation Available Inventory Amendment. To receive the promotional rates, CLEC must execute and submit this Amendment to Qwest, and CLEC must either: (1) have previously executed and submitted to Qwest the Collocation Available Inventory Amendment; or (2) execute and submit the Collocation Available Inventory Amendment concurrent with the submission of this executed Amendment.
