This report serves to inform the Commission, as required in Oregon Administrative Rule (OAR) 860-026-0035, that Energy Utilities who engage in Promotional Activities or Concessions must file an annual report with the Commission. While PGE did file a notice of promotional concessions, on November 25, 2020, for the 2021 calendar year with the Commission, pursuant to OAR 860-026-0025, PGE noted in previous years, these offerings were supported with SB 838 energy efficiency funding, and support energy efficient ducted and ductless heat pumps.

In 2021, PGE reports as follows:

Promotional Activity as defined in OAR 860-026-0010

Home Builders Association of Metropolitan Portland (HBA) Sponsorship and advertising \$90,000

PGE did not provide specific benefits or incentives to individual customers or builders—instead it is supporting the HBA to promote PGE's services more generally.

The benefits of PGE offering this Promotional Concession, which increases electric load among participating customers only incidentally, is to help customers decarbonize their energy footprint through electrification, by trading in gas powered landscaping tools and receiving an incentive to purchase a similar electric landscaping tool.
