
Pursuant to Order No. 10-414 issued in Docket No. UM 1355, Idaho Power Company ("Company") is providing information in compliance with Item No. 23 on page 8 of the settlement stipulation approved in the above matter. Because the enclosure is confidential and subject to General Protective Order No. 08-549, an original and one (1) copy of the confidential information will be provided via mail. The stipulation orders the Company to include an annual report on wind resources with its annual Results of Operations Report beginning with the 2010 edition. The report contains the following:

- a. Projected energy by month for the wind resource (MWh)
- b. Projected capacity factor by month for the wind resource (%)
- c. Actual energy by month for the wind resource (MWh)
- d. Actual capacity factor by month for the wind resource (%), and
- e. Energy variance by month (MWh) for the wind resource

In addition to the items listed above, the report includes the capacity factor variance by month. The term "availability" in the stipulation is defined by the operator as being available to produce energy.
