Pursuant to Order No. 10-414 issued in Docket No. UM 1355, Idaho Power Company ("Company") is providing information in compliance with Item No. 23 on page 8 of the settlement stipulation approved in the above matter. Because the enclosure contains commercially sensitive information detailing actual energy output by project name, it is confidential; therefore, an original and one copy of the confidential information will be provided via U.S. mail. The stipulation orders the Company to include an annual report on wind resources with its annual Results of Operations Report beginning with the 2010 edition. The report contains the following:
