RE: Supplemental Information for 2016 and 2017 Unused Energy Reports for Net Metering Facilities in 2015 and 2016

PGE filed unused energy reports for net metering facilities on July 1, 2016 and June 29, 2017 pursuant to Oregon Administrative Rule (OAR) 860-039-0060(3). The purpose of this supplemental filing is to correct the amount of unused kilowatt-hours and dollar amounts donated for the benefit of low income customers in those reports. This supplement only corrects the numbers provided in the previous reports. PGE still donated the correct amounts to Oregon Energy Services and Oregon Heat.

PGE previously excluded the kilowatt-hours and donation amounts associated with its PGE's solar payment option (SPO) customers¹. This report provides these amounts.

At the end of the billing year that concluded in March 2016, the unused SPO kWh credits were 159,949 kWh with a dollar value of \$4,676.78 calculated at the average annual avoided cost rate valued at 2.924 cents/kWh.

At the end of the billing year that concluded in March 2017, the unused SPO kWh credits were 166,270 kWh with a dollar value of \$4,325.99 calculated at the average annual avoided cost rate valued at 2.595 cents/kWh.

In 2016, PGE transferred the amount of \$49,385 to Oregon Energy Services, Inc², dba Oregon Heat. In 2017, PGE transferred the amount of \$38,365 to the Oregon Energy Fund, fka Oregon Heat³.
