In accordance with OAR 860-026-0025 and -0030, NW Natural submits this letter as notice of the promotional concessions that NW Natural plans to offer during the 2024 calendar year.

Each campaign may include one or more offers as set forth in the Company's Tariff P.U.C. Or. 25, at Schedule 200 "Promotional Concessions," and more specifically within one or more of these promotional areas:

- 200-2 General Merchandise Sales Program
- 200-3 Equipment Sales Promotions
- 200-4 Cooperative Advertising Program
- 200-5 Showcase Developments
- 200-8 Promotions for Company-Offered Products and Services

The campaign description and associated budget is as follows:

HVAC/Hearth/Water Heat Campaigns

The program budget is up to \$260,000.

Residential Builder Program and Campaigns

- This campaign includes residential new construction and multifamily programs.
- o The program budget is up to \$750,000.

• Dealer Relations Campaigns

o The program budget is up to \$50,000.

Cooperative Advertising Program

The program budget is up to \$20,000.

• Retail Program Campaign

- Advertising campaign for fireplaces and stove inserts \$50,000 (\$25,000 after manufacturer co-op).
- o Incentives for qualifying fireplace and stove inserts \$635,000. Energy Trust matching dealer contribution of \$200 each.
- Tankless water heaters and gas fireplaces \$2,000. Energy Trust dealer rebate on Sensei models.

- o Spring and Summer free delivery offer on grills \$5,000.
- The total program budget is up to \$667,000.

For most campaigns, participating dealers or trade allies will offer customer incentives for installing the promoted, natural gas appliances.
