Exelon Generation Company, LLC (Exelon Generation) is providing this report on behalf of the following in fulfillment of any OAR 860-024-0011(1)(b)(A) reporting requirements: Big Top, LLC; Butter Creek Power, LLC; Four Corners Windfarm, LLC, Four Mile Canyon Windfarm, LLC; Oregon Trail Windfarm, LLC; Pacific Canyon Windfarm, LLC; Sand Ranch Windfarm, LLC; Threemile Canyon Wind I, LLC; Wagon Trail, LLC and Ward Butte Windfarm, LLC.

### Threemile Canyon Wind I, LLC

Threemile Canyon Wind I, LLC does not own overhead electric supply facilities and hence has no overhead electric supply inspections to report.

## **Echo Projects**

Big Top, LLC; Butter Creek Power, LLC; Four Corners Windfarm, LLC, Four Mile Canyon Windfarm, LLC; Oregon Trail Windfarm, LLC; Pacific Canyon Windfarm, LLC; Sand Ranch Windfarm, LLC; Wagon Trail, LLC and Ward Butte Windfarm, LLC; collectively the Echo Projects; are co-owners of (1) certain electrical and communications facilities for the transmission electricity from the Echo Project's Collector Substation to PacifiCorp's Hinkle Substation and (2) a North-South 34.5kV overhead supply facility within the Echo Projects' collection grid—to the generator side of the Collector Substation. The Echo Projects do not own any other overhead supply facilities.

Exelon Generation reports that more than 50 percent of the Echo Projects' co-owned electrical and communications facilities noted in the paragraph immediately above were inspected within the first five years of the 10-year interval period. In fact, 100 percent of such facilities were inspected. Consequently, the next reporting on behalf of the Echo Projects will be made in 2024.
