Notice of Termination

### Dear Secretary Bose:

Pursuant to Section 205 of the Federal Power Act, 16 U.S.C. § 824d (2012), Part 35 of the Federal Energy Regulatory Commission's ("Commission") regulations, 18 C.F.R. Part 35 (2018), and Order No. 714¹ regarding electronic filing of tariff submittals, PacifiCorp hereby notifies the Commission that it is terminating PacifiCorp Second Revised Service Agreement No. 847, a Network Integration Transmission Service Agreement ("NITSA") between PacifiCorp and Exelon Generation Company, LLC ("Exelon"). The NITSA was entered into pursuant to PacifiCorp's Volume No. 11 Open Access Transmission Tariff ("OATT"). PacifiCorp respectfully requests an effective date for the termination of the NITSA of July 31, 2019, for the reasons described below.

# 1. Background and Reason for Filing

On December 31, 2018, PacifiCorp and Exelon executed the NITSA which describes the services provided to Exelon pursuant to Attachment M of PacifiCorp's OATT related to the Oregon Direct Access Program. On January 11, 2019, PacifiCorp filed the NITSA with the Commission, in Docket No. ER19-795. The Commission accepted the filing on March 6, 2019, via letter order<sup>2</sup> effective January 1, 2019.

The only Network Resource designated under the NITSA is a firm supply contract between Exelon and a third party that expires July 31, 2019.<sup>3</sup> As of the date of this filing, Exelon has not requested to designate a new Network Resource under the NITSA. Pursuant to its OATT, PacifiCorp provides Network Integration Transmission Service to deliver capacity and energy from a Network Customer's designated Network Resources to serve its Network Loads

on a firm basis.<sup>4</sup> In the absence of any designated Network Resource, PacifiCorp cannot provide Network Integration Transmission Service under the terms of its OATT. Pursuant to Section 4 of the NITSA, service under the NITSA shall terminate in accordance with the Tariff. Accordingly, in anticipation of the expiration of the supply agreement serving as Exelon's sole Network Resource under the NITSA, PacifiCorp now respectfully requests to terminate the NITSA effective July 31, 2019.

### 2. Effective Date

PacifiCorp respectfully requests that the termination become effective July 31, 2019. This notice is provided in compliance with 18 C.F.R. § 35.15(a) of the Commission's regulations, which requires sixty (60) days' notice prior to termination of a rate schedule, tariff, or service agreement by its own terms.

PacifiCorp has provided notice of this filing to Exelon.
