

Notice of Termination

Dear Secretary Bose:

Pursuant to Section 205 of the Federal Power Act, 16 U.S.C. § 824d, Part 35 of the Federal Energy Regulatory Commission's ("FERC" or the "Commission") regulations, 18 C.F.R. Part 35, and Order No. 714¹ regarding electronic filing of tariff submittals, PacifiCorp hereby notifies the Commission that it is terminating PacifiCorp Service Agreement No. 862 under PacifiCorp's Volume No. 11 Open Access Transmission Tariff ("OATT"), a Project Construction Agreement for the SVEC Paisley Generator TSR Project ("Construction Agreement") between PacifiCorp Transmission ("PacifiCorp") and PacifiCorp Energy Supply Management ("ESM"). PacifiCorp respectfully requests an effective date for this termination of September 17, 2019, for the reasons described below.

# 1. Background and Reason for Filing

On May 8, 2017, ESM and PacifiCorp entered into the Construction Agreement. The Construction Agreement sets forth the terms and conditions under which PacifiCorp agreed to perform and ESM agreed to pay for work to accommodate ESM's request for a new meter interconnection at or near Mile-Hi substation 69 kV tap to Surprise Valley Electrification Corporation (the "Project"). PacifiCorp filed the Construction Agreement with the Commission on May 19, 2017, in Docket No. ER17-1637. The Construction Agreement was designated as PacifiCorp Service Agreement No. 862. The Commission accepted the Construction Agreement for filing on June 20, 2017, effective May 8, 2017, via letter order.<sup>2</sup>

ESM has indicated to PacifiCorp that it no longer desires PacifiCorp to complete the Project. All costs incurred by PacifiCorp have been settled. PacifiCorp and EMS have mutually agreed to terminate the Construction Agreement effective 61 days from the filing date. Therefore, PacifiCorp now seeks to terminate the Construction Agreement, effective 61 days from the date the agreement is filed with FERC.

### 2. Effective Date
