Reference: Engineering and Construction Agreement

On August 24, 2018, PacifiCorp filed a Reimbursable Agreement for Engineering and Construction Activities (Agreement) with Bonneville Power Administration (BPA). PacifiCorp states that the Agreement sets forth the division of responsibilities between PacifiCorp and BPA to perform work, at BPA's expense, to move the Umatilla Electric Cooperative's McNary-Hermiston Generation 230 kV transmission line from the PacifiCorp Balancing Authority Area to the BPA Balancing Authority Area. Waiver of the Commission's notice requirements pursuant to section 35.11 of the Commission's regulations (18 C.F.R. § 35.11) is granted, and the Agreement is accepted for filing, effective August 25, 2018, as requested.

The filing was noticed on August 24, 2018, with comments, protests, or interventions due on or before September 14, 2018. No protests or adverse comments were filed. Notices of intervention and unopposed timely filed motions to intervene are granted pursuant to the operation of Rule 214 of the Commission's Rules of Practice and Procedure (18 C.F.R. § 385.214). Any opposed or untimely filed motion to intervene is governed by the provisions of Rule 214.
