RE: *PacifiCorp* Docket No. ER20-____-000 Notice of Termination

Dear Secretary Bose:

Pursuant to section 205 of the Federal Power Act ("FPA"), 16 U.S.C. § 824d, and Section 35.15 of the Regulations of the Federal Energy Regulatory Commission ("Commission"), 18 C.F.R. § 35.15, and Order No. 714¹ regarding electronic filing of tariff submittals, PacifiCorp hereby notifies the Commission that it is terminating PacifiCorp Rate Schedule No. 747, a Project Construction Agreement ("Agreement") between Bonneville Power Administration ("Bonneville" or "BPA") and PacifiCorp.

1. Background and Reason for Filing

On October 3, 2019, PacifiCorp and BPA entered into the Agreement. The Agreement set forth the design, installation and construction work to be performed by BPA and PacifiCorp to accommodate BPA's request that a 46 MW Lost Creek Generation Facility owned by the United States Army Corps of Engineers be moved from PacifiCorp's Balancing Authority Area ("BAA") to BPA's BAA. On October 16, 2019, PacifiCorp filed the Agreement with the Commission, in Docket No. ER20-127. The Agreement was designated as PacifiCorp Rate Schedule No. 747. The Commission accepted the filing on November 15, 2019, via letter order, effective December 16, 2019.

Section 2 (Term & Termination), subsection (2.2) of the Agreement states, in relevant part, that the Agreement "...shall terminate ninety (90) days after receipt of final payment of actual costs by Bonneville". On August 18, 2020, PacifiCorp received final payment from Bonneville. Accordingly, PacifiCorp now seeks to terminate the Agreement pursuant to its own terms.

2. Effective Date

In accordance with 18 C.F.R. § 35.15(a) of the Commission's regulations, PacifiCorp respectfully requests that the termination become effective November 16, 2020. November 16,

2020 is ninety (90) days from PacifiCorp's receipt of final payment from Bonneville, and, as discussed above, is the date that the Agreement will terminate according to its own terms.

PacifiCorp has provided notice of filing to the lone affected party, Bonneville.
