Pursuant to 18 C.F.R. § 35.15, Portland General Electric Company ("PGE") hereby submits this Notice of Cancellation of the South of Allston Transmission Path Allocation Agreement between PGE, PacifiCorp, and the Bonneville Power Administration ("BPA").

I. Description of Filing

The South of Allston Transmission Path Allocation Agreement was originally filed by PGE, acting as the designated filer, on March 14, 2007 as PGE Initial Rate Schedule FERC No. 15.¹ On June 1, 2018, PacifiCorp, acting as the designated filer, filed an amended South of Allston Transmission Path Allocation Agreement.² In their filing, PacifiCorp requested an effective date of June 1, 2018 and noted that the amended agreement supersedes the previous agreement of record.

PGE intends to file its concurrence to PacifiCorp's filing of the amended agreement with a requested effective date of June 1, 2018. As such, PGE requests that this Notice of Cancellation have the same effective date.

II. Effective Date and Waiver

PGE respectfully requests that the Commission accept this Notice of Cancellation, to be effective June 1, 2018. To the extent necessary, PGE seeks the Commission waive any additional
