1 Northwest Natural Gas Company, dba NW Natural ("NW Natural" or the 2 "Company"), hereby files with the Public Utility Commission of Oregon (the "Commission") this application ("Application") seeking reauthorization to use 3 4 deferred accounting pursuant to ORS 757.259 and OAR 860-027-0300, for the 12-5 month period beginning March 23, 2023 through March 22, 2024 for the annual 6 regulatory fee that NW Natural pays to the Commission pursuant to OAR 860-021-7 0034. 8 In Order No. 22-062, entered in this docket on February 24, 2022, the 9 Commission approved the Company's most recent request to continue deferring the 10 amount of the annual regulatory fee not captured in the Company's last general rate 11 case and temporary rates. On March 1, 2023, the Commission approved that the fee remain at 0.43 percent in Order No. 23-057. When the Company receives the 12 13 invoice from the Commission, a deferral of the previous year is recorded on the 14 Company books for the difference of the fee embedded in rates and the actual fee

## Description of the Expenses or Revenues for which Deferred

Accounting is Requested – OAR 860-027-0300(3)(a).

9 In this Application, the Company is requesting authorization to defer the costs

- 10 that represent the difference in the regulatory fee embedded in rates and the
- 11 regulatory fee established in Order No. 23-057 for calendar year 2022 gross
- 12 operating revenues. Specifically, NW Natural requests to defer the difference
- 13 between the annual fee amounts that are collected through rates and the annual fee.

14 E. Reasons Reauthorization of Deferred Accounting is Being Requested –

15 OAR 860-027-0300(3)(b).

16 ORS 757.259(2)(e) allows the deferral of utility expenses where necessary to 17 minimize the frequency of rate changes or the fluctuation of rate levels or to match 18 appropriately the costs borne by and benefits received by ratepayers. The Company requests deferral of the costs associated with the difference in the amount collected 19 20 and the actual regulatory fee. NW Natural does not seek to defer the costs 21 associated with the annual fee that have already been included in rates, and only 22 seeks to defer the incremental costs until such time as any increased fee amount can be included in NW Natural's established rates. While the amounts deferred may 23 24 not be significant, NW Natural seeks this reauthorization because the 2022 increase 25 to the annual fee was not a regularly scheduled event, which makes planning for any

fee increase difficult to align with ordinary rate case planning. The revenues received
from January to October 2022 had a lower fee embedded in rates. For this reason,
the Company respectfully requests the reauthorization to defer any incremental

## Accounting – OAR 860-027-0300(3)(c)

NW Natural proposes to account for the deferred expenses related to any
increased regulatory fee by recording the deferral in a sub-account of Account 186
(Defer PUC Fee). In the absence of deferred accounting, the Company would
record the incremental increase in expenses in the appropriate sub-account of
FERC Account 909.

## 11 G. Estimate of Amounts Subject to Deferral – OAR 860-027-0300(3)(d)

12 The Company estimates the amount to be recorded in the deferred account 13 for the 12-month period beginning March 23, 2023 through March 22, 2024 to be 14 approximately \$385,773.

## 15 H. Description of Entries Deferred Under UM 1766 – OAR 860-027-0300(4)(a)

16 The entries being deferred would reflect the incremental difference in the

17 regulatory fee embedded in rates and any new increased regulatory fee ordered by the

18 Commission.

## 19 I. Reason for Continued Deferral – OAR 860-027-0300(4)(b)

20 The deferral is forecasted to continue until a full calendar year of revenue

21 received from rates is consistent with the regulatory fee charged by the Commission.

22 The recovery of any incremental regulatory fee aligns the cost with the customers

23 who benefit from the governance the Commission provides.
