APPLICATION

1 Northwest Natural Gas Company, dba NW Natural (“NW Natural” or the
2 “Company”), hereby files with the Public Utility Commission of Oregon (the
3 “Commission”) this application (“Application”) seeking reauthorization to use
4 deferred accounting pursuant to ORS 757.259 and OAR 860-027-0300 for the 12-
5 month period beginning January 1, 2022 through December 31, 2022 for amounts
6 associated with NW Natural’s Multnomah County Business Income Tax (“MCBIT”),
7 as described in general Schedule A.

8 In support of this Application, NW Natural states:

9 **A. NW Natural**

10 NW Natural is a public utility in the State of Oregon and is subject to the
11 jurisdiction of the Commission regarding rates, service, and accounting practices.
12 NW Natural also provides retail natural gas service in the States of Oregon and
13 Washington.

1 **B. Statutory Authority**

2 This application is filed pursuant to ORS 757.259, which empowers the
3 Commission to authorize the deferral of expenses or revenues of a public utility for
4 later inclusion in rates.

30 **D. Description of the Expenses or Revenues for which Deferred**

31 **Accounting is Requested – OAR 860-027-0300(3)(a)**

32 NW Natural hereby requests the reauthorization to use deferred accounting
33 for any amounts that are over or under collected associated with the MCBIT

1 balancing account. The deferred amounts may result in an increase or decrease in
2 the MCBIT rate for the following year.

3 **E. Reasons Reauthorization of Deferred Accounting is Being Requested –**
4 **OAR 860-027-0300(3)(b)**

5 OR 757.259 is a “statutorily authorized exception to the general prohibition
6 against retroactive ratemaking” that allows a “means to address utility expenses or
7 revenues outside the utility’s general rate case proceeding.” Under ORS
8 757.259(2)(e), the Commission has discretion to authorize a deferral of “[i]dentifiable
9 utility expenses or revenues, the recovery or refund of which the commission finds
10 should be deferred in order to minimize the frequency of rate changes... or to match
11 appropriately the costs borne by and benefits received by ratepayers.” NW Natural
12 requests this deferral to match the costs borne and benefits received by customers.

13 **F. Accounting – OAR 860-027-0300(3)(c)**

14 Beginning on January 1, 2022 and ending 12 months from this date, NW
15 Natural proposes to account for the expenses and revenues associated with the
16 MCBIT by recording the deferral in Account 186. NW Natural proposes to amortize
17 the deferral as part of its adjustment to rates with its annual Schedule A filing
18 updating MCBIT expense.¹

19 **G. Estimated Amounts Subject to Deferral – OAR 860-027-0300(3)(d)**

20 NW Natural cannot estimate what amounts will be recorded in the MCBIT
21 deferral account for the upcoming 12-month period because the amount is

1 dependent on the actual tax assessed by Multnomah County and customer usage
2 which collects, on a variable basis, the revenues for the MCBIT.

3 **H. Entries into deferred account during past 12 months –**

4 **OAR 860-027-0300(4)(a)**

5 Pursuant to OAR 860-027-300(4)(a), NW Natural has deferred \$165,317 for
6 the months January 2021 through the date of this filing, which represents the
7 difference between the estimated tax provision and the collected amount from
8 customers subject to Schedule A.

9 **I. Reason for Continuation of Deferred Accounting – OAR 860-027-**

10 **0300(4)(b)**

11 The continuation of deferred accounting for the matters addressed above is
12 justified because they are continuing in nature.

13 **J. Requirement per Commission Order No. 09-263**

14 Below is the information required per Commission Order No. 09-263, issued
15 in Docket UM-1286, Staff's Investigation into Purchase Gas Adjustment ("PGA")
16 Mechanisms:

- 17 1. **A completed Summary Sheet, the location in the PGA filing, and an**
18 **account map that highlights the transfer of dollars from one account**
19 **to another.**

20 Exhibit A includes a Summary Sheet which shows the over collections at
21 year end 2020, the collections and provision for 2021 and the estimated
22 tax provision for 2022. It also describes the calculation of the 2022 MCBIT

1 rate. This deferral was not included for amortization in the 2021-22 PGA
2 filing. If the Company proposes amortization in the upcoming PGA filing,
3 Exhibit A would be attached to our electronic 2022-23 PGA filing as a file
4 entitled, "Proposed Temps Oregon 2022-2023 PGA....xlsx."

5 **2. The effective date of the deferral**

6 This application is for the 12-month period beginning January 1, 2022 and
7 ending December 31, 2022.

8 **3. Prior year Order Number approving the deferral**

9 Approval to use deferred accounting for amounts associated MCBIT
10 was last granted on January 13, 2021, in Commission Order No. 21-012.

11 **4. The amount deferred last year.**

12 \$71,000 was deferred for Oregon during the last deferral year of
13 November 30, 2020 through the most recent month, November 30, 2021.

14 **5. The interest rate that will apply to the accounts.**

15 There is no interest accrued on this account.

16 **6. An estimate of the upcoming PGA-period deferral and/or**
17 **amortization.**

18 NW Natural is unable to estimate the amount to be deferred during the
19 next PGA cycle. The Company's intent is to amortize for collection all that
20 is deferred.

1 **K. Notice – OAR 800-027-0300(3)(e)(6)**

2 A notice of this Application has been served to all parties who participated in
3 the Company’s last general rate case, UG 388, and is attached to this Application.

4 NW Natural respectfully requests that the Commission issue an order
5 reauthorizing the Company to defer the over and under collected amounts described
6 in the Application associated with MCBIT.
