17	one violation of law, OAR 952-001-0070.

19	Both parties to this proceeding are willing to forego further processing of that Complaint		
20	and further are willing to resolve this matter on the basis of this Stipulation.		
21	3.		
22	Although the Defendant admits that the violation was committed as alleged in the		
23	Complaint, the Defendant contends that the violation was the result of actions by its designated		
24	agent, and not by the Defendant. Nevertheless, the Defendant admits that it bears responsibility,		
25	and thus is willing for the Commission to enter an order finding that the violation was		
26	committed as alleged in the Complaint.

2	The parties_further_agree that the Commission may enter an order assessing a civil	
3	monetary penalty against Defendant in the amount of \$1,000 under the following terms and	
4	conditions:	
5	А.	Defendant must sign and return this Amended Stipulation within 14 days of the date
6		it was served upon (mailed to) Defendant.
7	B.	\$200 becomes due and payable on or before the 30 <sup>th</sup> day following the
8		Commission's entry of its order in this case.
9	C.	Payment must be by <b>money order or company check</b> made out to the <b>Public</b>
10		Utility Commission of Oregon, and the memo line of the money order must state
11		the "NC" docket number in the caption of this Amended Stipulation.
12	D.	Payment of the balance of the penalties (\$800) will be permanently suspended and
13		no further penalties will be imposed for the violation alleged in the Complaint unless
14		Defendant fails to comply with all of the terms of this Stipulation and all of the rules
15		adopted by the Oregon Utility Notification Center (OUNC) under ORS 757.552 for a
16		one-year period following the date of the Commission's entry of an order.
17	E.	In the event that Complainant contends that Defendant has not complied with all of
18		the terms of this Stipulation and all OUNC rules for that one-year period,
19		Complainant may reopen this proceeding and petition for imposition of all or a
20		portion of the suspended penalties. In such case, Defendant is entitled to a hearing
21		and to be notified of the basis upon which Complainant contends that compliance
22		has not occurred.
23	F.	Complainant's failure to enforce any provision of this Stipulation, or decision to
24		waive any violation or nonperformance of this Stipulation in one instance, will not
25		constitute a waiver by the Complainant of that provision, any other provision, or any
26		other violation or nonperformance in another instance.
