STAFF RECOMMENDATION:

Staff recommends the Public Utility Commission of Oregon (Commission) approve Portland General Electric's (PGE or Company) filing of ADV 1494/Advice No. 23-06, making housekeeping changes to Tariff P.U.C. No. 18, effective for service on and after May 17, 2023.

DISCUSSION:

lssue

Whether the Commission should approve ADV 1494/Advice No. 23-06, PGE's proposed revision to the Table of Contents and Summary of Applicable Adjustments pages of Tariff P.U.C No. 18.

Applicable Law

ORS 757.205 requires public utilities to file all rates, rules, and charges with the Commission.

ORS 757.210 establishes a hearing process to address utility filings and requires rates to be fair, just, and reasonable.

OAR 860-022-0025 requires that filings revising tariffs include statements showing the change in rates, the number of customers affected and resulting change in annual revenue, and the reasons for the tariff revision.

<u>Analysis</u>

Background

In this Advice Filing filed April 7, 2023, PGE explains that the references to Schedule 152 Major Event Cost Recovery were inadvertently omitted from the PUC Tariff No. 18 Table of Contents and Schedule 100 Summary of Adjustments when a separate Advice Filing (Advice No. 22-36, ADV 1453 for Schedule 153) was submitted and approved earlier this year.

Staff reviewed filing ADV1453/Advice No. 22-36, which became effective for service on and after March 10, 2023, and confirmed that the Table of Contents, Forty Second Revision of Sheet No 1-3 and the Summary of Applicable Adjustments, Eighth Revision of Sheet No. 100-2 omit the necessary reference to Schedule 152.

The revised Table of Contents, Forty Third Revision of Sheet No. 1-3 and Summary of Applicable Adjustments, Ninth Revision of Sheet No. 100-2 in filing ADV 1494/Advice No. 23-06 corrects the Table of Contents and the Summary of Adjustments pages by adding the reference to Schedule 152.

Conclusion

Based on Staff's review of PGE's Tariff P.U.C No. 18 and the proposed revisions, Staff recommends that the Commission approve PGE's ADV 1494/Advice No. 23-06. The proposed changes have no impact on customer rates.

The Company has reviewed this memo and agree with its contents.
