- **SUBJECT:** <u>QWEST CORPORATION:</u> (Docket No. ADV 860/Advice No. 2146) Compliance filing with Order No. 18-014 in Docket No. UD 29 to move the CenturyLink Business Package, the Home Phone Extra Package, and the CenturyLink Business Bundle, from the regular tariff to the price list.

I have reviewed this filing and recommend that an acknowledgement letter be sent.

By this filing Qwest Corporation d/b/a CenturyLink QC (Qwest or Company) moves the CenturyLink Business Package, the Home Phone Extra Package, and the CenturyLink Business Bundle, to the company's price list in compliance with Order No. 18-014 in Docket UD 29. This filing was submitted on October 31, 2018, with a proposed effective date of December 1, 2018. The company also submitted a related tariff filing, Advice No. 2018-006-PL, to add the packages and bundle to the Qwest Corporation Exchange and Network Services Price List.

Applicable Rule or Law

On November 30, 2017, Qwest filed a petition to price list the Residential Unlimited Nationwide Calling Bundle and two packages and one bundle for Business, pursuant to ORS 759.054 and OAR 860-032-0035. The Business Packages are the CenturyLink Business Package, the Home Phone Extra Package, and the CenturyLink Business Bundle. The Commission issued its Order No. 18-014 granting the petition on January 18, 2018. The Company moved its Nationwide Calling Bundle to the Price List effective April 11, 2018. This filing completes the compliance with Commission Order No. 18-014.

Order No. 18-014 sets the following conditions: (1) the regulated telecommunications services included in the bundle shall remain separately available in the companies' tariffs or price lists, (2) the total price of the bundle, once price listed, shall not exceed the sum of the tariffed/price-listed rates of the individual components, and (3) the companies shall make price list changes at least one day prior to the effective date of those changes.

<u>Analysis</u>

The present filing does not make any changes to the rates, terms, or conditions of service for the moved packages and bundles. Upon moving to the price list, future changes to these packages and bundles may become effective upon filing with one day's notice to the Commission pursuant to the successive price plans adopted in Docket No. UM 1354, Order No. 14-346 and Docket UM 1908, Order No. 18-359.

Conclusion

This filing complies with all applicable laws and Commission orders. The filing should be allowed to go into effect, and an acknowledgement letter should be sent. No further action is necessary.
