10	Consistent with the schedule in this docket, the Public Utility Commission of Oregon		
11	Staff (Staff) files this opening brief. PacifiCorp's Amended Tax Report is consistent with		
12	applicable statutes and rules and should, therefore, be accepted. Furthermore, Staff does not		
13	object to PacifiCorp's proposed amortization of the surcharge amount.		
14	DISCUSSION		
15	On October 15, 2007, PacifiCorp submitted its tax report for the 2006 tax period. See		
16	Staff/100, Owings-Ball/2, line 6-7. Staff reviewed PacifiCorp's tax report and requested certain		
17	revisions to the tax report based upon Staff's review. See generally Staff/100, Owings-Ball/2-6.		
18	PacifiCorp performed Staff's requested revisions. See PPL/203; PPL/200, Fuller/4, line 6		
19	through Fuller/5, line 8; see also Staff/100, Owings-Ball/7, lines 5-10. Finally, Staff's review		
20	concluded that PacifiCorp's amended tax report was consistent with the applicable statutes and		
21	rules. See Staff/200, Owings-Ball/7, line 17 through Owings-Ball/8, line 3.		
22	PacifiCorp proposes to amortize \$27 million of the surcharge through Schedule 102 in		
23	2008-09 and defer the rest of the surcharge to its SB 408 balancing account. See PPL/100,		
24	Larson/3, lines 7-11. Staff does not oppose PacifiCorp's amortization proposal.
