- 1. <u>PacifiCorp Presentation:</u> We ask PacifiCorp to make a 10-15 minute presentation with updates on new information or changes to its planned action items since its Integrated Resource Plan (IRP) was filed in October 2019, particularly addressing the impact of the recent extension of the Production Tax Credit (PTC). Commissioners will ask questions, and may allow questions from Staff and stakeholders.
- 2. <u>Staff and Stakeholder Comments:</u> Staff and stakeholders may each take approximately 5 minutes to summarize the most important points the Commission should consider in acknowledgement review.
- 3. Roundtable Discussion of General Issues: Commissioners will lead questioning of PacifiCorp, Staff and stakeholders in two general areas: (a) PacifiCorp's resource needs and evaluation of new resource options, including demand-side, supply-side and transmission resources; and (b) details of PacifiCorp's planned request for proposal (RFP), including maximum amount of resource procurement and interaction with generator interconnection queue reform. Topic areas not covered in this workshop will be carried over to the next workshop, noticed below.
