On June 28, 2019, Idaho Power Company filed its 2019 Integrated Resource Plan (IRP). On January 31, 2020, Idaho Power filed its Amended 2019 IRP Application. Idaho Power presented an overview of its Amended IRP via teleconference on March 31, 2020. The procedural schedule includes April 21, 2020, as a Commission Workshop date.

The following workshop agenda provides for a Commission Workshop that will allow the Commissioners to discuss Idaho Power's Amended 2019 IRP general topics with Staff, the company and stakeholders.

We adopt the following agenda for the April 21 workshop:

- 1. <u>Staff overview of comments</u>. After Staff's summary of their comments, Idaho Power will have time to respond to each issue. Comments from other stakeholders on each topic will be invited as time permits. Topics will include:
  - i. Aurora LTCE Portfolio Modeling
    - 1. Manual Adjustments to WECC-optimized portfolios
    - 2. Selection criteria (cost deviation and planning scenario)
    - 3. Jim Bridger exit dates
  - ii. Clean by 2045 and thermal resources
  - iii. Transmission
    - 1. B2H Partnership
    - 2. Gateway West
  - iv. Jackpot Solar

- 2. Stakeholder Issues
  - i. Demand Response (CUB and STOP B2H Coalition)
  - ii. Coal Retirements (Sierra Club and CUB)
  - iii. Avoided Costs (Renewable Energy Coalition)
- 3. <u>Stakeholder comment on topics not listed above</u>. Stakeholders will be given five minutes to discuss issues from their comments that were not covered above and/or to pose questions to Idaho Power and/or Staff.

Staff will lead discussion of the issues in the first part of the workshop. For each issue, Idaho Power will have an opportunity to respond after Staff's presentation, and stakeholders interested in individual issues will also be provided with an opportunity to provide brief comments supplemental to the discussion of that issue.

The second part of the workshop will provide a chance for stakeholders to present an overview of each individual issue listed in that section, with the expectation that the stakeholder listed next to each issue will begin the discussion. The company will be provided an opportunity to respond, and other interested stakeholders and Staff may provide additional perspective on that issue.

Finally, stakeholders may provide brief perspective from their comments on topics not discussed in the first two parts, and/or to pose questions to Idaho Power and Staff. Commissioners may ask questions of the parties or comment during any of the three parts of the workshop.
