NOTICE OF SPECIAL PUBLIC  
MEETING AND AGENDA

The Commission will hold a workshop to further discuss the issues raised in PacifiCorp, dba Pacific Power's 2021 Integrated Resource Plan (IRP) proceeding. The workshop will be held in two separate parts.

First, shortly after the Commission opens the Public Meeting, it will convene an Executive Session under ORS 192.660(2)(f) to consider information that is exempt from public disclosure related to coal issues. The Executive Session is open only to signatories of protective Orders Nos. 21-271, 21-399, and members of the media, who may attend but are prohibited from reporting on information discussed in the executive session. Once discussion involving confidential information is complete, the Commission will move into public session and the Administrative Hearings Division (AHD) will send an email to the service list stating that the public session is beginning.
