On June 25, 2018, the Commission will conduct an examination of witnesses in dockets UM 1910, UM 1911, and UM 1912. Testimony in these dockets has been offered by PacifiCorp, dba Pacific Power; Idaho Power Company; Portland General Electric (PGE); The Oregon Solar Energy Industries Association (OSEIA); Renewable Northwest (RNW); Oregon Department of Energy (ODOE); the Oregon Citizen's Utility Board (CUB); and Commission Staff.

NOTICE OF COMMISSIONER EXAMINATION AND MEMORANDUM The Commission examination will proceed in three formally separate hearings. Each hearing will begin with questions from Commissioners and the Administrative Law Judge (ALJ), followed by any reserved cross-examination within the scope of the examination and requested re-direct. The Commissioners will begin with docket UM 1910. Once Commission examination is completed of witnesses in UM 1910, the proceeding will be closed and the process will be repeated for dockets UM 1911 and UM 1912. Cross-examination of witnesses will be conducted, as applicable, in the following order: Utility, OSEIA, RNW, ODOE, CUB, and Staff.

Below the witnesses are identified for questioning and general scope of inquiry, as well as order of examination. More witnesses are included for questioning in docket UM 1910 than in dockets UM 1911 and UM 1912. This is due to the fact that there may be generic, non-utility specific questions for some witnesses that span the various proceedings and involve universally applicable issues. In the interest of efficiency, questions will be asked during the UM 1910 proceeding rather than in each individual hearing. As necessary, official notice will be taken of the UM 1910 hearing transcript in dockets UM 1911 and UM 1912 to ensure a full and complete record in all three proceedings.

It is noted that where a party has provided joint testimony or where witnesses have provided overlapping testimony, it will be left to the sponsoring party to identify the appropriate witness for questioning, based on the topic to be explored. The following topics have been identified only to provide witnesses with some guidance in preparation for the hearing. The right to ask questions is reserved on subjects beyond those listed below.
