1. Independent Evaluator Presentation on PacifiCorp's Final Shortlist and Sensitivities (1.5 hrs)

Since our July 8 Commission Workshop, PacifiCorp has filed an updated final shortlist (FSL) and the IE will be filing comments on PacifiCorp's sensitivities on August 2. The primary purpose of this workshop is to review the IE's comments on the sensitivities.

2. Brief Summary from PacifiCorp on its Updated Filing and Other Topics of Interest (1 hr)

While the IE will have already summarized many key points from PacifiCorp's updated filing, PacifiCorp will have the opportunity to make a brief summary of additional points.

We also ask PacifiCorp to continue to address topics of interest that were highlighted in the last workshop agenda. Please see the July 8 agenda for examples of charts we have found informative in past proceedings.

- Transmission costs associated with the final shortlist.
- Forecasted nominal revenue requirement impact that customers will experience from the FSL procurement.
- Amount of expected off-system sales and purchases relative to the most recent available actual operations.
- We add a request to expand the chart on expected future emissions from the FSL portfolio to also include the most recent available past emissions from actual operations.

3. Staff and Stakeholder Comments (30 mins)

We will open the floor for Staff and stakeholders to add comments or other questions of interest.
