DISPOSITION: MOTION TO SUSPEND SCHEDULE GRANTED;

PREHEARING CONFERENCE SCHEDULED;

PARTIES TO FILE ARGUMENT

On October 16, 2013, the Industrial Customers of Northwest Utilities (ICNU) filed a motion to suspend the procedural schedule in this docket and to schedule a prehearing conference to determine a new schedule. ICNU represents that all parties support, or do not oppose the motion, and requests expedited treatment of the motion due to imminent due dates in the docket. The motion states that all parties except PacifiCorp, dba Pacific Power, and Portland General Electric have reached a comprehensive settlement of all issues in this proceeding. The motion further states that Pacific Power disputes whether the parties' settlement, codified in a filing made on October 14, 2013, is a proper stipulation under OAR 860-001-0350. ICNU adds that the stipulating parties and Pacific Power request the opportunity to provide argument on whether the October 14th filing is a settlement contemplated by Commission rules, or instead a joint common position statement that may supersede earlier filed individual testimony.

The motion to suspend the schedule is granted. A prehearing conference to set a new schedule for additional testimony, hearings, and briefing, will be held as follows:
