On February 13, 2014, Portland General Electric Company filed tariff sheets in Advice No. 14-03 with the Public Utility Commission to be effective March 18 2014. By Order No. 14-055 entered February 18, 2014, the Commission suspended the rate filing for a nine month period until December 17, 2014.

The purpose of the prehearing conference will be to identify parties and establish a procedural schedule. To assist the parties in their task, the Commission directs the parties to pattern the proposed schedule after that adopted for PGE's last general rate case, docket UE 262, with five rounds of testimony. *See* Prehearing Conference Memorandum March 6, 2013.<sup>1</sup> Parties are advised, however, that
