Note: The access code for the February 11 workshop differs from the code used for the first two workshops.

These workshops, as well as three (3) public comment periods to be announced at later dates, will constitute Phase III of the Generic Capacity Investigation. As discussed in the Staff memo presented at the April 23, 2019 Public Meeting, in Phase III Staff will collaborate with the utilities and stakeholders to develop appropriate method(s) to calculate a value for capacity, and Staff will present these recommendations to the Commission. Per the April 23, 2019 Commission order:

- Methodologies could be consistent across utilities, but based upon the value to each utility's system
- Methodologies may need to vary by resource type / characteristics

Staff will consider the following questions, among others:

- Currently, simple-cycle gas plant costs are generally used to value capacity. Is this still the correct approach?
- Should consideration of flexibility, and potential ancillary services offered by resources be included?
- Should supply-side and demand side resource be valued in the same way?
- Should multiple approaches be considered in valuation, or can a one-price fits all method work?

Staff will circulate a more detailed agenda prior to each of the three (3) workshops. Each of the three (3) public comment deadlines, along with questions to help focus those comments, will be announced at a later time.

There is no need to RSVP. The meetings are open to the public. All interested parties should be sure they are on the UM 2011 Service List to ensure receipt of future announcements.
