DISPOSITION: PROCEDURAL SCHEDULING MOTION GRANTED IN PART; EXPEDITED ANSWER ORDERED ON REMAINDER.

PacifiCorp d/b/a/ Pacific Power (PacifiCorp) filed a motion proposing bifurcation of this proceeding as well as a new procedural schedule for both bifurcated phases. PacifiCorp states that its motion is generally unopposed except that intervenor NewSun Energy, LLC does not support the proposed schedule.

I agree that the proceeding should be bifurcated as proposed by PacifiCorp and therefore grant its motion for bifurcation. I also adopt its proposed schedule for the first phase of the proceeding as set forth below.

PacifiCorp does not indicate whether NewSun opposes the schedule for the first phase of the bifurcated proceeding or whether its opposition is solely due to the dispute over hearing dates referenced in PacifiCorp's motion. However, the first date in PacifiCorp's schedule is October 7, 2022, one day after its motion was filed. Therefore, in the interests of expediency, I will grant this schedule prior to receiving a response from NewSun. To the extent NewSun believes that future dates in this schedule need to be altered, it may state so in its response.

In order that a schedule may be set in the second phase of this proceeding in a timely manner, NewSun should file any response to PacifiCorp's motion by 3:00 pm on Tuesday, October 11, 2022.

Finally, the parties should be aware that while we will attempt to accommodate the hearing dates proposed by the parties (whether on the faster or slower proposed schedules), other Commission proceedings may make that impossible. Therefore, the parties may be asked to consider additional dates.

The schedule on which the first three stipulations filed in this case, as well as the remaining Direct Access issue, will be considered is as follow:
